## **Chapter 1**

## **Information and safety**

## **1.1** About this manual

This user and maintenance manual is published to help you to get started with your **BABYSCREEN** device from the initial receipt, through commissioning, use and maintenance.

If you have any difficulty in understanding this manual, contact your dealer/distributor or the manufacturer, Électronique du Mazet.

This document must be kept in a safe place, protected from atmospheric agents, where it cannot be damaged.

This document ensures that the devices and their documentation are technically up-to-date at the time of marketing. However, we allow ourselves to make changes on the device and its documentation without any obligation to update these documents.

In the case of transfer of the device to a third party, it is mandatory to notify Électronique du Mazet about the new owner information's. The device must be provided to the new owner with all documents, accessories and packaging.

Only staff aware of the content of this document are allowed to use the device. If the instructions contained in this document are not followed, Électronique du Mazet and its distributors disclaim all responsibility about consequences of accidents or damage on staff or third parties (including patients).



## **1.2** Presentation of the device

The **BABYSCREEN** is designed for screening, documentation and monitoring of hearing function. It is intended for use by otolaryngologists, pediatricians and other healthcare professionals in offices and hospitals. The hearing of a subject can be evaluated objectively, without requiring the subject's participation, via evoked potentials or induced otoacoustic emissions. The evoked potentials term refers to the collection of the electrophysiological activity induced by acoustic stimuli. It allows the diagnosis of neurosensory and retrocochlear damages.

The provoked otoacoustic emissions term indicates the collection in the external auditory meatus of a sound wave induced by an acoustic stimulation. These sounds of low amplitude are the reflection of the smooth running of the external hair cells active mechanisms. They allow the diagnosis of the neurosensory damages but also pressure disorders of the internal ear.

**BABYSCREEN** is based on a system of measures modules, which can be entirely purchased from the acquisition of the equipment or be added in a later update.

### 1.2.1 Intended Use

The **BABYSCREEN** is a device dedicated to health professionals who want to perform objective hearing screenings, whether on newborns, young children or even adults. It allows for rapid and automated measurements of PEA, TEOAE and DPgram. The launching of the measurement as well as the reading of the result, in the form of "PASS", "REFER" are simplified so that unqualified staff in otology can carry out and exploit the measurements following a short training.

By using different acoustic stimuli (click, sinusoid, complex signals) and different recording methods (acoustic or electro-physiological), the **BABYSCREEN** is designed to perform the following otologic diagnostics:

### **1.2.4** Contraindications

We recommend not to diagnose (or to take precautions when diagnosing) patients with injured skin, open wounds or acoustic hypersensitivity

The contraindications are not exhaustive and we advise the user to seek advice in case of doubt.

## 1.3 Warnings

In this manual the warnings and information given have the following meaning:

The <b>caution</b> label indicates conditions or process that may expose the patient and/or user to a risk.
The <b>warning</b> label indicates conditions or process that could cause the device malfunction.
The <b>information</b> label refers to notices or information that are not related to any risk of accidents or malfunction of the device.



<u>**CAUTION**</u>: The device must be handled by a qualified operator (hospital staff, doctor, etc.). The patient must not come into contact with the device other than through the accessories.

<u>**CAUTION**</u>: The device must be connected to a computer with a certified medical power supply (double insulation according to ISO 60601-1)

<u>CAUTION</u>: No modifications to the device are permitted. It is strictly forbidden to open the device housing.

<u>CAUTION</u>: This equipment complies with applicable electromagnetic compatibility standards. If you experience interference or other problems with another device, contact Électronique du Mazet or the distributor for advice on how to avoid or minimize the problem.

<u>**CAUTION**</u>: Operation in close proximity (e.g., 1 m) to shortwave or microwave therapy EM equipment may cause instabilities in the output power of the STIMULATOR

<u>CAUTION</u>: Using the device close to other high frequency devices may produce errors in measurement recording. It is advice to make measurement at more than one meter of high frequency sources.



<u>CAUTION</u>: The device must be used with accessories given compatible by the manufacturer (see 1.2.7).



<u>**CAUTION**</u>: The device must not be accessible to the patient. It should not be placed in contact with the patient.



<u>CAUTION</u>: the computer must never be located in a space accessible to the patient



<u>CAUTION</u>: Be sure to follow the maintenance instructions listed in the 6.Maintenance and servicing

<u>CAUTION</u>: The battery can only be replaced by Électronique du Mazet technicians or their distributors.





<u>CAUTION</u>: The device collects data. The practitioner is in charge to comply with the EU General Data Protection Regulation 2016/679 (or the local laws of the personal data protection). When returning to the After Sales Service, the practitioner must delete the data so that it is not disclosed.

## 1.4 Residual risks

Applied parts that are too old or of poor-quality can impair the quality of contact with the patient and cause discomfort. Make sure to regularly change the parts.

Microbes or viruses can be transmitted from one patient to another via the applied parts. Make sure that the hygiene conditions recommended by the manufacturer of the applied part are observed.

If water enters the device, it may not function properly. In this case, unplug the device and disconnect the cables. In any case, avoid the presence of water in the vicinity of the device.

#### 1.4.1 Shutdown of the device during its operation

In case the device is shutdown during its operation,

- In stand-alone mode: the measurement in progress will stop; the continuous saving of the measured data avoids losing the measurements made up to that point.

- When connected to the computer: the computer continuously saves the data, the measurement can be saved before closing the software.

#### 1.4.2 Special use case

No specific cases identified. See section 1.2.4 for contraindications.

## 1.5 Commissioning

Check that the device is not damaged; if you have any doubts about the integrity of the device and its proper functioning, contact Électronique du Mazet or your distributor.

If the device was stored in a cold place and there was a risk of condensation, let the device rest for at least 2 hours at room temperature before switching it on.

Before using the device for the first time, cleaning it and its accessories is recommended, see section 6.

#### **1.5.1** Charging the device

The device is delivered with a USB cable. You can choose between two ways of charging your device, via a computer or via the USB power (see 1.2.7). Once plugged in, the charge starts automatically and an electrical plug logo is displayed in the title bar. This logo appears in grey when the **BABYSCREEN** is charging and in green when the battery is fully charged.

The device battery is charged before shipment; however, it is recommended to charge it before the first use (we advise you to charge it for 12 hours before the first use).

When using the solution of connecting the device to a computer via the USB cable, charging will be slower than via a USB power adapter (see 1.2.7).



It is preferable to charge/discharge the battery as fully as possible to ensure a long service life. Charge the device to its maximum capacity and only charge it when it has reached a critical battery level.

To disconnect the device from the power supply, the USB power adapter must be disconnected.

## **1.8** Patient data confidentiality

The device collects data. It is the practitioner's responsibility to apply and comply with the European Parliament's General Data Protection Regulation 2016/679. When returning the device to the after-sales service, the user must delete the patient data from it so that it is not disclosed. The practitioner has the possibility to make a backup copy of the data by saving them in the **ECHOSOFT** software (see section 5.3.1) before deleting the patients from the device (see section 5.3.2.2).

The **BABYSCREEN** device is intended to be used by authorized healthcare professionals only. To ensure the confidentiality of patient data and to prevent disclosure to unauthorized third parties, a password can be set at the first start of the device. Please refer to section 2.1.3 for more information.



**ECHODIA** advises you to regularly renew the password of your device. It is also advisable to activate the lock mechanism of the computers on which you have installed the **ECHOSOFT** software after a short period of inactivity.

## 1.9 Cybersecurity

As the device and its **ECHOSOFT** software are computer-based systems that are integrated into larger information systems, certain rules and good practices must be put in place to ensure the safety of patients and users. Électronique du Mazet does not provide or control the operating environment of its products, so it is the responsibility of the practitioner to ensure that the following recommendations are followed.

## 1.9.1 Good practices for computer security

-Keep your software up to date, including the operating system (Windows or MacOs)

-Use operating system accounts to manage access.

-Use strong passwords to access accounts

-Lock down the computer when not in use

-Back up the **ECHOSOFT** database regularly (see 5.4)

-Verify the authenticity of any third-party software you install

-Use anti-virus software and a firewall

-Since the device and ECHOSOFT do not need to access the Internet, isolate the computer from the network as much as possible.

-Check echodia.com periodically to see if updates are available.

## **1.9.2** Technical Information

-The ECHOSOFT software is a Java program

-It embeds its own java execution environment (JRE+JVM) in order not to interfere with other software. (installed in the same folder, by default : *C:\Program Files\Echodia\Echosoft\jre*)

-The configurations of the software as well as the database are saved in the *.echosoft* folder of the user folder (ex: *C:\Us-ers\romain\.echosoft*).

-The software uses the port 32145 of the local loop (localhost / 127.0.0.1) in order to check that there are not several instances of the software launched at the same time.

-The software uses a proprietary USB driver to communicate with the device



## **Chapter 2**

## General information about using BABYSCREEN

## 2.1 Initial Start-up of the device

### 2.1.1 Switching on / starting

The device can be turned on without any other part connected (OAE probe, EchoDif). Turn on the power using the switch on top of the device (if it does not start, make sure the device's battery is charged)

#### 2.1.2 Touch screen calibration

For the first start-up, it is necessary to calibrate the touch screen. The following window appears:

The screen has to be calibrated at 5 different points. Simply hold the stylus down on the cross at the center of each of the circles that appear successively.

Calibration is important for comfortable use. It is highly advisable to calibrate the device while holding it on a table, and using the stylus.

#### 2.1.3 Password

After the screen calibration, the password definition windows appear. If you choose to set up a password, it will be asked to you each time you start the device. To do this, click on "Lock the device with a password" and set your password by clicking on "Change Password". The password must contain between 1 and 15 characters, and will be asked twice in order to ensure the proper seized of it.



You can access the password configuration window later from the "Measure" then "System" menu. This window allows you to change the password, but also to activate or deactivate the locking.

If you forget your password, please contact Electronique du Mazet or your reseller to receive an unlocking code.



## 2.1.4 Home screen

Once this step completed, the homepage appears:



Several items of information appear on this page. First, it contains the 3 possible selection parameters when the device is starting:

- **USB**: enables to activate the USB port of the device in order to recover, store and analyze the measurements made with it on a computer.
- Measure: this is the main mode used for making and consulting measurements.
- **Config**: configuration of the various device options.

The homepage is used for choosing the system language by clicking on the flags at the bottom left of the screen.

At the bottom right, the serial number of your device is displayed.

A title bar is present on all windows of the device. From left to right, it contains:

- The current window title.
- The charge indicator (grey: charging. Green: charged).
- The date and time.
- Tha battery level.
- A button for returning to the previous window (on the homepage screen, it is used for switching off the device).

## 2.1.5 Switching off the device

To turn off the device, you can click on the back button at the top right of the home screen. A shutdown confirmation message will appear:

It is also possible to press the power button on the top of the device to bring up this screen from any browser window.

Energy saving mode: when you are not measuring, the device automatically turns off after 5 minutes of inactivity.



It is possible to force the device to turn off by holding down the power button at the top of the device during 4 seconds.



#### 2.2 **General device configurations**

Some of the device general operating parameters can be configured. Accordingly, it is possible to set the time, date, brightness and orientation of the screen. To do this, just enter the configuration menu from the main screen.

The date and time can be configured from the "Date and Time" window

The "LCD" menu allows you to adjust the brightness of the screen with an adjustable gauge. The "Rotation" button allows the display to be rotated by 180°. This can be useful depending on the location and position in which the device is used. It is also possible to recalibrate



The change to and from daylight saving time is not automatic.



the touch screen.

It is possible that some drifting appears after using the tactile screen for some time (several months) (e.g.: clicking on the buttons becomes less accurate), in which case screen re-calibration is necessary.

The "System" button informs you about the hardware and software version of the device, and the amount of free memory space on the **BABYSCREEN** device.

The « Data factory reset » button resets the measurement parameters to the default values.

If you choose to set up a password lock, you will be asked for it every time you start the device (see 2.1.3).

The «About» menu contains the contact details of the company Electronique du Mazet.

The "**Calibration**" menu allows the consultation of the acoustic calibration values defined for your device.

Don't modify this value, only Electronique du Mazet or your reseller are approved to realize this calibration.



The **BABYSCREEN** device must be calibrated once every year to guarantee the quality of the measurements. Please contact your retailer to plan this calibration.



Some of these options require a password to be changed. This is the serial number of your device, indicated on the back of it on the S/N line. This number is also displayed at the bottom right of the home page.

## 2.3 Advanced configurations

### 2.3.1 Otoacoustic emission (OAE) configurations

There are different protocols for collecting and studying otoacoustic emissions. If you are accustomed to a specific protocol, the **BABYSCREEN** device allows you to define your own configurations.

A bad setting can make the next measurements unusable and irrelevant.

In the main menu of the device, click on "**Config**". The settings window opens. Click on "**Config OAE**" to access the advanced otoacoustic emissions settings. A password will be required to be able to change the default settings. The password is the 8 digits of the device serial number. The serial number can be fund on the label located on the back of the device or at the bottom right of the home screen.

If you have any doubts about the configuration set, click on "**Reset data**" to return to the parameters displayed at the factory configuration.





Config DP-gram : Access to the DP-gram measurement settings

Config TEOAE : Access to the TEOAE measurement settings

**DP Frequency Config :** set the frequency gap between the 2 stimulation frequency F1 and F2 for *Shift-OAE* and *DPgram* measurement. The value set is the ratio between F1 and F2 (1.2 by default) :

$$F1(Hz) = \frac{F2(Hz)}{X}$$

The "2 * F1 - F2" and "2 * F2 - F1" check-boxes allow to choose which distortion product will be investigated in the **Shift-OAE** and **DP-gram** curves

These two parameters are available for Shift-OAE and DPgram.

#### 2.3.1.1 Config DP-gram

If you are not familiar with the settings and how modifying them can affect the test results, do not try to change them. Incorrect settings can make future measurements inoperable and irrelevant.

The DPgram configuration window allows you to modify the test parameters (test frequencies and difference between L1 and L2 intensities) and customize validation criteria. Changes to the protocols should only be made by qualified personnel.

#### 2.3.1.2 Config TEOAE



If you are not familiar with the settings and how modifying them can affect the test results, do not try to change them. Incorrect settings can make future measurements inoperable and irrelevant.

The TEOAE configuration window allows you to modify the validation criteria for the "**screening mode**". There are two ways to validate the presence of OAE:

- Validation by the number of frequencies detected for a given value of the signal-to-noise ratio.
- Validation by statistical analysis.
- For this second case, the detection is based on the cor-



relation between the two buffers, the stability of the response and the presence of an OAE signal. Thus, the settings for the minimum SNR value and the number of frequencies for validation are disabled. Protocol changes should only be performed by qualified personnel

For acoustic and physiological reasons, the frequency reliability of the TEOAE test is between 2Khz and 4KHz, the validation criteria with a minimum number of frequencies above 3 can make the test slow and prone to false negatives.



#### 2.3.1 Selection of the connected Jack headphone

In most cases, the unit comes with only one headset, which is properly configured at the factory. ## 2.4 Patient management

BABYSCREEN offers ideal measurement organization thanks to an advanced patient-based management system.

From the home page, select the "Measure" mode, leading to the choice of seeking an existing patient or creating a new one.

## 2.4.1 Create a new patient

If you choose to create a new patient, only 4 items of information are requested, the **name**, **first name**, **date of birth and gender**.



The correct indication of "Weeks of Pregnancy" (the length of gestation) is important to avoid false negatives in premature babies.

To enter this information, just click on the desired field to have the keyboard appearing on the screen. It is possible to use a digital keypad by clicking on the "123" key at the bottom left.

By entering the patient's date of birth and gender, it is possible to plot the audio metric normals or to display the normal wave latencies in PEA.



To create a new patient, it is essential to specify a name and a first name. It is also recommended to specify a birth date, this allows a better patient organization in the **ECHOSOFT** data base.



The date must be entered in format **DD/MM/YYYY** (day/month/year). **BABYSCREEN** device automatically formats your enter.

Here, the information about the patient is kept brief. You can enter more details when you export the data to the **ECHOSOFT** program. Refer to paragraph 5.3.

## 2.4.2 Patient follow-up

After you have created the patient, his or her record is recorded on the memory card. You can then find it by clicking on the "**Search**" button.

This brings up a table containing the list of patients, in the opposite order to the recording (the last added patient appears at the top of the list).

The list of patients appears with names, first names and dates of birth. The magnifying glass icon at the bottom of the screen enables to search for a patient thanks to his/her name or surname.

To select a patient, click on the corresponding line. This opens a new page summarizing information about the patient.

Now, it becomes possible to choose to make a new measurement (diagnosis) or to consult those previously saved (consultation).



If the patient does not yet have a measurement, only the «Diagnosis» button is visible.

The "**Consultation**" button opens a table of measurements allowing to consult the diagnoses previously made for this patient.

To find the desired measurements, the main information is displayed (type, date, time and ear).

The color of the "ear" field will be green for the "PASS" test or red for the "REFER" test.

The "**Diagnosis**" button allows to choose the new measurement to be made.

## Chapter 3

## **ABR measurement**

## 3.1 Presentation

#### ABR: Auditory Brainstem Response

Auditory Brainstem Response, also known as brainstem auditory evoked potentials are widely used both in the field of neurological exploration and ENT. It is a non-invasive electrophysiological technique based on the principle of electroencephalography (EEG), it provides objective test, reproducible information about the auditory function, from the cochlea to the brainstem.

It shows electrical activity of peripheral auditory pathways following application of an acoustic stimulation (most often a click) in the overall activity of the EEG. **ABR**'s therefore use an averaging technique to reveal the specific auditory electro-physiological responses (improvement of the signal-to-noise ratio).

**ABR** techniques are widely used for exploring the nerve conduction in the auditory pathways, latency **ABR** (presentation of acoustic stimulation at a set intensity of 80dBnHL for instance) and thus revealing all the malfunctions evident in these auditory pathways: acoustic neuroma, demyelinating diseases (multiple sclerosis, leucodystrophy...), all retro-cochlear diseases and auditory neuropathy.

Furthermore, by applying acoustic stimulations of decreasing intensity, ABR's make it possible to objective hearing threshold for each ear (threshold ABR). The ABR's inform us about the possible presence of cochlear pathologies (perception deftness with a rise of the auditory thresholds) but also about the possible presence of diseases in the middle ear (shift of the curves).

Typical **ABR** plots consist of several waves numbered from I to V. In the case of latent **ABR's**, (neurological tracing), the waves I, III and V must be clearly identified in a context of normality, with presence variability for waves II and IV. These waves must appear in a normality range.

Any increase of this latency time is a sign of a conduction problem, and suggests that additional investigation is necessary.

Conventionally, and for clarity and simplicity's sake, it is accepted that wave I is generated by the distal portion of the auditory nerve, wave II by the proximal portion, wave III by the cochlea core and wave V by the inferior colliculus contralateral to the stimulation.

Within the scope of auditory threshold research, analysis of the **ABR** is centered on the evolution of wave V in the course of decreasing intensity. The intensity at which wave V "disappears" is then associated with the intensity of the auditory threshold for the test ear.


**ABR**'s is a way to objectively and non-invasive evaluating auditory function and nerve routes on newborn, child, adult whether awake, anesthetized/sedated as in spontaneous sleep (without any alteration).



## 3.2 Equipment



## 3.3 Patient setup



Simplified 3 points setup



These instructions must be adapted depending of the ear(s) tested, in every case the **red** color corresponds to the **right** ear, the **blue** color to the **left** ear.

The state of the options **"3 points wiring"** and **"Tube"** are saved for the next measures, however, the power setting is always set back to 40 dB to be replaced in screening conditions.

- Connect the electrophysiological cable to the ECHO-DIF. Connect the ECHO-DIF Mini-DIN on the AUX connector.
- For measurement with the insert earphone, put the tip on the **left** and **right** earphones. Then, connect the earphone Mini-DIN to the **«Audio»** connector of the **BABYSCREEN** unit.



If you have the « pediatric kit », you can use the acoustic tubes with OAE ear tips connected on the insert earphone instead of the foam ear tip (the **«tube**» option must be activated on the software).



- To make measurement with **DD45 headset**, connect the headset cable on the Jack plug of the **BABYSCREEN** (indicated with the headset icon).
- Clean the surface of the skin where the electrodes will be attached with abrasive gel. This decreases the impedance of the skin. Depending on the contact being used, it may be necessary to remove the deposit with a cleaning agent (such as alcohol).
- Attach an electrode (**minus**) in the middle of the forehead, just below the hairline. The positioning of the other electrode (**Patient Reference**) is far less strict. This electrode can be placed on the forehead, on the temple or on the chin.



- In the case of the 4 points wiring, the electrodes V+ and V+ must be attached behind the ear to be tested (on the mastoid).
- In the case of the 3 points wiring, only the electrodes V+ must be attached to the base of the neck. Ce câblage est recommandé pour le dépistage de la surdité du nourrisson, mais il n'est utilisable que si le patient ne tient pas encore sa tête.
- Connect the electrode in the middle of the forehead (minus) with the Black clip and the Patient Reference with the Green clip.
- In the case of the 4 points wiring, the **Red** clip must be connected to the electrodes placed behind the **Right** ear and the **Blue** one behind the **Left** ear. The **Right/Left** switch is automatically done.
- In the case of the 3 points wiring, the **Red** clip must be connected to the electrodes placed in the base of the neck. The **Blue** clip stay unconnected.
- Insert the ear tips plug on **Blue** acoustic stimulator in **left** ear. Insert the ear tips plug on **Red** acoustic stimulator in **Right** ear. The **Right/Left** switch is automatically done.




The speed and accuracy of the measurement depend mainly on the child's condition. Ideally, the baby should be sleeping and as relaxed as possible.

## 3.4 Measurement

#### **3.4.1** Setting up the measurement parameters

Once the screening **ABR** diagnosis has been selected its configuration window appears. Those parameters are described below.



- **"Power"**: conventionally the new born screening test should by made between 35 and 40 dB, however it is possible to modify this value, but beyond 50 dB the device shows a warning message indicating that at this power the measure is not a screening test.
- «Chirp» : instead of click stimulation, the device will use Chirp (Chirp is anly available in screening mode)
- "3 points wiring": use a setup based on only 3 electrodes instead of the classical 4 electrodes. Rather than using the red and blue electrode on the corresponding mastoid, it is possible to only use the ref one on the new born neck.
- Button "Wiring": show an illustration on how to put the electrodes on the newborn
- «Tube» : tick the box if you use the acoustic stimulator with tube.

Select «Right» or «left» to start the measurement.



The state of the options **"3 points wiring"** and **"Tube"** are saved for the next measures, however, the power setting is always set back to 40 dB to be replaced in screening conditions.



### 3.4.2 Measurement

When launching the measure, if the electrodes are not well placed or not well connected, an impedance verification window is shown.

The impedance values have to be the smaller and the most balanced as possible to provide the most reliable



If value V- is greater than  $10k\Omega$ , wipe the patient's forehead again and reattach new electrodes.




If value V+ is greater than  $10k\Omega$ , check that the mastoid (or the neck, depending on the chosen wiring) electrode is properly placed. If necessary, wipe the patient's mastoid again and reattach new electrodes.

The **ABR** measurement window opens, click on "**Start**". The measure will begin, ensure that the patient is not too agitated during the measurement.



Two stacked curves are displayed, they are built turn by turn. This measurement method enables to calculate the correlation between the two curves.



The rejection indicator warns you when the rejection threshold is reached. If it stays locked on red it means that the patient muscular activity is too high. When the patient will be more relaxed, the measurement will automatically resume. If this problem remains, the electrode eventually needs to be replaced to reduce the impedance, otherwise, the test should be reported when the patient will be less agitated.

The "Stop" button and the top right cross enable to stop the measurement.

3.5 Measurement consultation


In a normal use, the measure will automatically stop:

If the maximum measurement time has been reached and wave V is not detected, then the device cannot validate the measurement.

If the correlation between the two curves is good and the two markers for the wave V are placed at the same place, then the test validated.

In both case it is possible to directly save the measurement or to consult it before choosing to save it or not.

## 3.5 Measurement consultation




When consulting a screening ABR, the above window is displayed and allows to process the curves. The first aim of a screening ABR is to locate the wave V at a relatively low power. This wave presence will allow to give a negative or positive diagnosis about the patient hearing.

The wave plotting and the measure validation is automatically done during the acquisition but the device also provides some consultation tools to fine tune the result:

- At the top of the screen, there are buttons relative to each marker. Click on one of the buttons to move the corresponding marker over the curves. To guide positioning, "normality" zones are grayed out and the marker is positioned by simply clicking on the curve.
- The "Auto" button automatically places the V marker. If the wave is not significant enough or if it leaves too much the areas of "normality" it will not be placed.
- At the bottom right there is a button for adjusting the timescale of the curves making it possible to display 5 ms, 10 ms or 20 ms (corresponding to the time elapsing after the stimulation click).





## **Chapter 4**

## **Otoacoustic emission (TEOAE and DP-gram)**

## 4.1 Presentation

The cochlea, the peripheral organ of hearing, is capable of emitting low-amplitude sounds in response or not to acoustic stimulation. These sounds are easily recorded in the external auditory canal using a sensitive miniaturized microphone. The genesis of these sounds coming from the cochlea, called otoacoustic emission, depends on the proper functioning of specific cells in the cochlea: the outer hair cells (OHC). In addition, the integrity of the eardrum and the ossicular chain is also necessary for the transmission of the acoustic stimulation wave and for the propagation of the physiological response from the cochlea to the eardrum.

#### **4.1.1 TEOAE**

**TEOAE** : Transient otoacoustic emissions.

When we speak about otoacoustic emissions, we primarily think about the transient otoacoustic emissions also called TEOAE which are most used in clinical examination. The OAE are recorded by a small probe placed in the external ear canal. The detection of transient otoacoustic emissions (TEOAE) is a real asset in the battery of audiometric tests.

The TEOAE are otoacoustic emissions per click, that is to say that we will test the patient ear at frequencies between 2000 Hz and 4000 Hz. The result is represented by a curve that indicates if the otoacoustic emissions are present or not. This is an objective test because it does not require the cooperation of the patient.

This test is very important, especially in the examination of newborns, because if otoacoustic emissions are present it means that the newborn hearing does not have a deafness higher than 30-40 dB. This is a routine screening test, more and more used in the newborns examination.

#### 4.1.2 DP-gram

DP-gram: Otoacoustic Emission Distorsion Product Phase Shift Graphic

During the recording of the distortions product otoacoustic emission (DPOEA), a bi-tone acoustic stimulation is applied. This particular stimulation brings two specific regions close to the cochlea into action and leads to the excitation of a third cochlear region. The OHC's excited in this way, because of their contraction property, will put the basilar membrane into movement, driving the endolymphatic fluid and finally connecting the ossicles to the eardrum. Put into vibration, the eardrum will emit a low amplitude sound (1: 10000) which can easily be recorded and identified.

These two stimulating sounds, called primary sounds, have respective frequencies of f1 and f2 and will generate the emission of a characteristic distortion product for humans at a frequency of 2f1-f2. For instance, with the presentation of 2 primaries f1=1000Hz and f2=1200Hz, the expected distortion product will be 2f1-f2 = 800Hz. The generated distortion product is lower in frequency and smaller in amplitude than the primaries. It is the amplitude of the distortion product that will be considered as a criterion for evaluating the cochlear function and more specifically the OHCs of the emitting region (at a frequency of 800 Hz in this example). Accordingly, a distortion product having an amplitude of more than 7 dB with respect to the background noise will be the signature of the presence and functionality of the OHCs in the emitting region.




By varying the frequencies of the 2 primaries f1 and f2, it is possible to gather together the different distortion products and establish a curve known as **DP-gram** (a graphic of the distortion products, similar to an audiogram). By observing the cochlear spectrum, from 1000 Hz to 5kHz, we can estimate the impairment severity of the OHCs and thus estimate the level of deafness.

This makes the **DP-gram** a simple and fast test which can be reproduced and which, above all, is not invasive. The presence of PDAs allows us to affirm (when there is no transmissional deafness) the cochlear functionality of the OHCs. The **DP-gram** study is recommended for the early screening of deafness at the maternity stage, following up infants in neonatology intensive care units, in pediatric audiological evaluation, in following up abrupt deafness, professional and toxic deafness.



4.3 Setup





Using an otoscope, make sure that the ear canal is not obstructed by ear-wax. This operation must be carried out by a qualified person.

- The choice of the right EarTip is particularly important for the quality of the measurement. You can choose from 10 different sizes. The tip must provide the following functionalities:
  - 1. It must ensure that the probe is held securely in the patient's ear.
  - 2. It must not be pressed against a wall of the ear canal.



- 3. It must be hermetically sealed to prevent acoustic leaks and isolate from the noise.
- Fit the tip to the probe.
- Insert the probe in the patient's ear canal.





## **4.4 TEOAE**

Refer to paragraph 2.3.1 to obtain the necessary instructions about the needed equipment and the setup.

#### 4.4.1.1 Measurement


The **BABYSCREEN** is a screening device, so there is no special configuration required. After connecting the OAE Probe, all you have to do is select the ear when starting the measurement.



The validation criteria and the maximum test duration can be modified in the advanced setting of the TEOAE (see subsection 2.3.1.2). In this menu, it is also possible to modify the intensity used in **« Screening »** mode.



If you are not familiar with the settings and how modifying them can affect test results, do not attempt to change them. A bad setting can make the next measurements unusable and irrelevant.



The **TEOAE** measurement window opens, click on "Start".


This first step of the measurement is a self-calibration which last few seconds (2 or 3 seconds). During this first step, the surrounding noise must be kept as low as possible.

At the measurement beginning, click calibrations are performed automatically to determine if the measurement conditions are optimal to obtain usable results. In this context, the system inform the user that the conditions are not good:

- "Low signal. Check leak. Continue?": The click signal is to low compared to his set value (at least 5dB to low). This may be due to the wrong positioning of the probe, more precisely a sealing problem between plug's probe and the ear canal. It is advised to click on "No", reposition the probe and restart the measure. However, if you are sure of the probe's positioning, it is possible to continue by clicking "Yes".
- **"Too much signal, Check eartip. Continue?"**: The click signal is to strong compared to his set value (at least 5dB to strong). This may be due to the wrong positioning of the probe, more precisely if the probe is to deep in the ear canal. It is advised to click on **"No"**, reposition the probe and restart the measure. However, if you are sure of the probe's positioning, it is possible to continue by clicking **"Yes"**.

Once the calibration is done, the measurement window appears :





- On the left side:
  - The rejection indicator light notifies you when the rejection threshold is reached. This phenomenon indicates that the patient moves or, in common way, that there is too much noise. When the noise will go down, the measure will automatically resume
  - Indicator of the stimulation quality: in a good measurement condition, the gauge should be green and half filled. If the gauge moves or change of color, this is because of a bad positioning of the probe, or a clogged probe.
- The graph show :
  - In the left part, the shape of the stimulation



If the click shape doesn't look like the above illustration (sinusoid amortized on a few oscillations) check the probe position in the ear then restart the measurement.


- In the central part, the two buffer (A and B) that are currently recorded.
- At the bottom of the screen:
  - The number of clicks, which informs you of the progress of the measurement, the sum of the two buffers (A and B) must reach the number of stimulations entered in the configuration window.
  - The correlation between the A and B buffers
  - o Number of rejections for each buffer
  - Detection analysis, which works only in detection mode. It shows how many frequencies have been validated or how many statistical criteria have been satisfied, depending on the validation mode chosen. (See subsection 2.3.1.2).

The "**Stop**" button stops the measurement prematurely but the data is not lost, you will be able to consult the measurement. You then have the choice of saving the data by clicking on "**Save**" or deleting it by exiting from the window using the back cross.

mode the device stops the measurement when the validation criteria are satisfied. On the other hand, if the maximum test duration is reached, the measurement is stopped and the device indicates a non-conclusive test.






End of a test that can't be validated

#### 4.4.2 Measurement consultation

The **TEOAE** reading is done on three screens. Each one gives different information. (temporal, frequency, synthetic).

By default, the click data ("stim" check box on the bottom of the screen) are not displayed.

- On the first screen there is the same display as during the measure, the temporal view, with the click shape on the left and the two TEOAE curves (or buffers) on the center. Superposing the curve help to see if the TEOAE is present and if there is a reproducibility between the curves (if they are superposing or not).
- The second screen is the frequency view.
  - Upper graph: click spectrum. If the probe is correctly placed, the maximum click spectrum should be reach between 2KHz and 4KHz.
  - Lower graph: Noise spectrum in red and signal spectrum in green (the signal really generated by the inter ear). If the cochlear signal is present, the green spectrum (signal) should exceed the red one (noise).
- The last screen summarizes in a digital manner the previous information. Namely, the ratio between the signal and the noise as well as the reproducibility rate for each frequency.

The sheet cases become green or red to indicate that the ear correctly respond to the different frequencies. The validation criteria are:

- Signal noise ratio upper than 9 dB and repeatability upper than 50%
- Signal noise ratio upper than 6 dB and repeatability upper than 60%
- Signal noise ratio upper than 3 dB and repeatability upper than 75%

These criteria simply represent a help to the measurement reading. They don't have medico legal value.



For physiological acoustic reasons, the reliability in frequencies of the TEOAE test is between 2Khz and 4KHz, the 1Khz and 5Khz information are only indicative.



## 4.5 DP-gram

Refer to paragraph 2.3.1 to obtain the necessary instructions about the needed equipment and the setup.

#### 4.5.1.0 Measurement

The **BABYSCREEN** is a screening device, so there is no special configuration required. After connecting the OAE Probe, all you have to do is select the ear when starting the measurement.



Frequencies to be tested, validating conditions and maximum duration of the test can be modify in the advanced setting of the DP-gram (see subsection 2.3.1.1). In this menu, it is also possible to modify the intensity used in **« Screening** » mode.

The **DP-gram** measurement window then opens. The curve is displayed with default values (0dB for the signal,

-25dB for the noise) on frequencies that were selected during configuration.

Click on the "Start" button to start measurement.





This first step of the measurement is a self-calibration which last few seconds (2 or 3 seconds). During this first step, the surrounding noise must be kept as low as possible.

For each frequency, a series of calibrations are performed automatically to determine if the measurement conditions are optimal to obtain usable results. In this context, the system may asks the user to make choices in order to adjust the measurement parameters as best as possible:

- "Low signal. Check leak. Continue?": The signals F1 and F2 and are too low compared to their set value (at least 20dB too low). This may be due to the wrong positioning of the probe, more precisely a sealing problem between the probe plug and the ear canal. It is advised to click on "No", reposition the probe and restart the measure. However, if you are sure of the probe's positioning, it is possible to continue by clicking on "Yes".
- **"Too much signal, Check eartip. Continue?"**: The signals F1 and F2 and are too strong compared to their set value (at **least** 20dB too much). This may be due to an incorrect positioning of the probe, more precisely a probe plug pushed too far into the ear canal. It is advised to click on "No", reposition the probe and restart the measure. However, if you are sure of the probe positioning, it is possible to continue by clicking on "Yes".

Once the calibration is complete, the measurement window is displayed:





A progression bar informs you of the state of progress of a point. When the progression bar stops, the system updates the point corresponding to the frequency being tested. This graph contains several kind of information :

- 1. The green curve represents the power of the distortion product in dB at the various selected frequencies.
- 2. The index given in white above a point is the power of the distortion product.
- 3. The vertical white figures indicate the test frequency for each points.
- 4. The red curve represents the average noise level.

The rejection indicator light notifies you when the rejection threshold is reached. If 40 successive rejections are detected, the current point is rejected and the "**Rejection**" information appears on the screen. This phenomenon indicates that the acoustic noise is too high. There can be several causes for this:

- 1. The patient noise is too high. When the patient is more relaxed, measurement will start again automatically. If the phenomenon persists, it means that the rejection threshold has been calibrated too low. Exit from the measurement by clicking on "**Stop**" then restart a new measurement.
- 2. The probe is incorrectly positioned. It is possible that the probe moves during measurement, in particular if you are running postural tests. In this case, click on "**Stop**", replace the probe (paragraph 4.3) and make another measurement.
- 3. The ambient noise is too high. The intrinsic noise in the room where you are making the measurement must not exceed 60 dB.

The "**Stop**" button stops the measurement. Once the data acquisition is over, the curve is reconstructed. You then have the choice of saving the data by clicking on "**Save**" or deleting it by exiting the window using the back cross.

the device switches to the next frequency when the validation conditions are reached or after having reached the maximum test duration. After having tested all the selected frequencies, the device stops the measurement and indicates whether the test is valid or not conclusive, depending on the number of frequencies at which the distortion product (DP) was recorded.

At the end of the measurement, a popup shows if the test is valid or not.





### 4.5.2 Measurement consultation



This graph contains several items of information:

- The green curve represents the power of the distortion product at the various selected frequencies in dB SPL.
- The white number above a point is the power of the distortion product.
- The vertical white numbers indicate the test frequency for each point.
- The red curve represents the average noise level.
- A reminder about the measurement conditions (power and number of simulations) is given at the bottom of the window
- On each point there is a validation (or not) mark.
- In screening mode, there is an indication of the measurement validation or not.

### 4.5.2.1 Advanced analysis tools

**BABYSCREEN** includes a high-performance tool palette that giving you the opportunity of analyzing directly on the touch screen (without any computer support), all the data you have collected.

Click on one of the points of the curve. A window including a data analysis table appears. It contains several items of information concerning the investigated signal.

The column in green represents the distortion products investigated in the previous phase graph. This value can be modified. Refer to paragraph 2.3.1.1.



### Point spectral analysis

To run spectral analysis of the signal by a Fast Fourier Transform (FFT) click on the "**Freq**" button.


The power distribution graph (abscissa) with respect to the frequency (ordinate) appears. The effective spectral energy zone is indicated by a vertical white line.

In the opposite example, 3 other spectral rays can be identified with high power levels to the right of the effective spectral energy zone. From left to right, stimulation frequency F1, followed by F2 and finally secondary distortion product (2 * F2 - F1).

#### Point time analysis

To start the time analysis of the signal, click on the "**Temp**" button. The cursor enables you to adjust the maximum time value of the display window.

For this type of measurement, the general form of the time signal can easily be identified. It represents the modulation of stimulation frequencies F1 and F2.

### 5.2.2 Installation des pilotes USB

**BABYSCREEN** has a generic USB driver mass storage, it is recognized and installed automatically. This driver will enable the transfer of the data collected in ambulatory mode in the ECHOSOFT's data base.



To optimize the life length of the battery, the screen will turn off after two minutes when the USB mode is activated and that the device is plugged to a computer. To turn it back on, click on the "On/Off" button or touch the screen.



## 5.3 Patient management

The ECHOSOFT software is capable of reading measurements made using BABYSCREEN. it incorporates a database in which the patient data and measurements can be stored.

### 5.3.1 Import patient from device

Connect the device to the computer to import patient data into the ECHOSOFT.

Start the device and connect it to the computer using the supplied USB cable. From the homepage screen, select the "USB". The device should be detected by the computer.

For the first plug of the device, the USB driver should be automatically installed. See subsection 0.



Start the **ECHOSOFT**. Go to the section entitled "**Device**" then click on "Data".

If the device is connected properly and the USB driver is running, the list of patients is refreshed automatically.

There are then 3 possibilities for importing the patient and making measurements:

– Add a patient to the data base

- Synchronize all patients with the data base

- Synchronize all patients with the data base in fast mode






#### 5.3.1.1 Add a patient to the datebase

Select the patient(s) to be imported from the list, then click on "**Save to database**". The software will then ask you for the information for the whole selection before importing the data.

To register a patient in the database, it is necessary to indicate the doctor or the operator who performed the measurements. If the operator already exists in the database, it is sufficient to select him and then click on Validate. If not, it is possible to create a new one (see the paragraph on how to create an operator). The "**Cance**l" button imports the patient, but does not associate any operator to the measurements

A detailed patient information form is provided. You can add information such as address, phone number, etc. Once filled in and validated, a series of treatments is executed by the software.

If the patient has been correctly imported, his name appears in the "Patient" section of ECHOSOFT.



If several patients in the database are likely to correspond to the patient being imported, **ECHOSOFT** offers the possibility of choosing the corresponding patient or simply creating a new one.

### 5.3.1.2 Synchronize all patients with the database

This option lets you add all of the **BABYSCREEN** patients to the **ECHOSOFT** database. The software will automatically scan the list of patients on the **BABYSCREEN** to add them to **ECHOSOFT**, if the patient does not exist, a new patient file will appear to be filled. On the contrary if the patient is already on the database, it will automatically be synchronized.

If you select some patients in the list before launching the registering in the database, the software only synchronize the patients that have been selected. If you have a large amount of patient stored on the device, making a selection enables to synchronize rapidly your data.

#### 5.3.1.3 Synchronize all patient with the database in fast mode


This option lets you add all of the **BABYSCREEN** patients to the **ECHOSOFT** database with only one click.

The software will automatically scan the list of patients on the **BABYSCREEN** to add them to the **ECHOSOFT**, if the patient does not exist it will be automatically created with the information present on the device. On the contrary, if the patient is already present on the database, it will automatically be synchronized.

This synchronization has the advantage of not requiring any intervention from the user.

### 5.3.2 Delete a patient

Using ECHOSOFT it is possible to delete patient recorded in the database and patient recorded on the device.

### 5.3.2.1 Delete a patient from ECHOSOFT

A patient can be deleted from the **ECHOSOFT** database via the "**List of patients**" window in the "**Patient**" section. The "**Edit patient's profile**" button is used to consult and modify the contact records of the patient selected in the list. The "Delete" button is used to definitively delete the patient from the ECHOSOFT database.




## 5.9 Bilateral display and printing







## Chapitre 6

# **Maintenance and servicing**

## 6.1 Periodic checks

Before testing, consider checking:

- The presence of the acoustic stimulus and the correct power calibration.
- The absence of interference in the incoming signals.
- The general functioning of the device.

Replace the unit and its peripherals in the original case after each use.

The **BABYSCREEN** device is reliable and safe for the patient. In order to maintain this safety, it is imperative to follow the operating instructions provided in this manual.

**BABYSCREEN** devices are designed to have a service life of 5 years.



To ensure that the performance of the device is maintained throughout its life, it is necessary to have the device checked by Electronique du Mazet technicians or its distributors every year.



All cables supplied are made of EMI resistant materials. To maintain these properties, it is advisable not to bend, pinch or pull the cables.



Surface electrodes have an expiry date, so be sure to check this date before each use.

## 6.2 Cleaning



This device is not sterile, Accessories are not sterile

### 6.2.1 Device case

The device case only requires normal, periodic cleaning of its external surface, which may become dirty.

The touch screen should be cleaned with a soft, dry cloth, **without any product or water**. Clean the rest of the appliance only with a dry or slightly wet cloth.



Do not use any liquid or spray to clean the unit, as this may damage the electrical circuits.



### 6.2.2 Accessories

In order to ensure perfect hygiene, it is essential to systematically clean all material and equipment in direct contact with the patient.



All consumables (surface electrodes and ear tips) are disposable, discard them after use.

The practitioner has the possibility to make a backup copy of the data by saving them in the **ECHOSOFT** software (see 5.3.1) before deleting patients from the device (see 5.3.2.2).

## 6.4 Transport and storage
