Chapter 1

Information and safety

1.1 About this manual

This user and maintenance manual is published to help you to get started with your AUDIOSMART device from the initial receipt, through commissioning, use and maintenance.

If you have any difficulty in understanding this manual, contact your dealer/distributor or the manufacturer, Électronique du Mazet.

This document must be kept in a safe place, protected from atmospheric agents, where it cannot be damaged.

This document ensures that the devices and their documentation are technically up-to-date at the time of marketing. However, we allow ourselves to make changes on the device and its documentation without any obligation to update these documents.

In the case of transfer of the device to a third party, it is mandatory to notify Électronique du Mazet about the new owner information's. The device must be provided to the new owner with all documents, accessories and packaging.

Only staff aware of the content of this document are allowed to use the device. If the instructions contained in this document are not followed, Électronique du Mazet and its distributors disclaim all responsibility about consequences of accidents or damage on staff or third parties (including patients).

1.2 Presentation of the device

AUDIOSMART is designed for screening, documentation, monitoring and diagnosis of hearing functions. It is intended for ENT doctors, audiologists, pediatricians and other health professionals practicing in private or in a hospital environment. The audiometry is a behavioral examination allowing to quickly assess the hearing acuteness. Via an acoustic stimulator, sounds, words or sentences with various sound intensities are presented to the subject. The subject reports his or her perception to the operator who can, according to the test used, determine an absolute threshold of perception or an intelligibility threshold.

1.2.1 Intended Use

The audiometric diagnostic test is a behavioural test for the rapid assessment of hearing ability. The subject is exposed to sounds, words or phrases at different intensities using an acoustic stimulator. He/she transmits his/her perception to the operator who, depending on the test used, can detect a reduction in hearing acuity, determine an absolute threshold of perception or an intelligibility threshold. Two modes of transduction can be used, through the normal auditory pathways using an acoustic transducer (Air conduction), or using a vibrator placed on a bony part such as the mastoid or the forehead (Bone conduction).

1.2.2 Target population

Ages: The device can be used on any type of patient with the ability to respond to the presence or absence of an acoustic stimulus (>5 years)

1.2.4 Contraindications

We recommend not to diagnose (or to take precautions when diagnosing) patients with injured skin, open wounds or acoustic hypersensitivity

The contraindications are not exhaustive and we advise the user to seek advice in case of doubt.

1.3 Warnings

In this manual the warnings and information given have the following meaning:

<u>**CAUTION**</u>: The device must be handled by a qualified operator (hospital staff, doctor, etc.). The patient must not come into contact with the device other than through the accessories.

<u>CAUTION</u>: No modifications to the device are permitted. It is strictly forbidden to open the device housing.



<u>CAUTION</u>: This equipment complies with applicable electromagnetic compatibility standards. If you experience interference or other problems with another device, contact Électronique du Mazet or the distributor for advice on how to avoid or minimize the problem.

<u>CAUTION</u>: Operation in close proximity (e.g., 1 m) to shortwave or microwave therapy EM equipment may cause instabilities in the output power of the STIMULATOR



<u>CAUTION</u>: The device must be used with accessories given compatible by the manufacturer (see 1.2.7).



<u>**CAUTION**</u>: The device must not be accessible to the patient. It should not be placed in contact with the patient.



<u>CAUTION</u>: the computer must never be located in a space accessible to the patient

<u>CAUTION</u>: Be sure to follow the maintenance instructions listed in the 6.Maintenance and servicing





<u>CAUTION</u>: The battery can only be replaced by Électronique du Mazet technicians or their distributors.

The device collects data. The practitioner is in charge to comply with the EU General Data Protection Regulation 2016/679 (or the local laws of the personal data protection). When returning to the After Sales Service, the practitioner must delete the data so that it is not disclosed.

1.4 Residual risks

Applied parts that are too old or of poor-quality can impair the quality of contact with the patient and cause discomfort. Make sure to regularly change the parts.

Microbes or viruses can be transmitted from one patient to another via the applied parts. Make sure that the hygiene conditions recommended by the manufacturer of the applied part are observed.

If water enters the device, it may not function properly. In this case, unplug the device and disconnect the cables. In any case, avoid the presence of water in the vicinity of the device.

1.4.1 Shutdown of the device during its operation

In case the device is shutdown during its operation,

- In stand-alone mode: the measurement in progress will stop; the continuous saving of the measured data avoids losing the measurements made up to that point.

- When connected to the computer: the computer continuously saves the data, the measurement can be saved before closing the software.

1.4.2 Special use case

No specific cases identified. See section 1.2.4 for contraindications.

1.5 Commissioning

Check that the device is not damaged; if you have any doubts about the integrity of the device and its proper functioning, contact Électronique du Mazet or your distributor.

If the device was stored in a cold place and there was a risk of condensation, let the device rest for at least 2 hours at room temperature before switching it on.

Before using the device for the first time, cleaning it and its accessories is recommended, see 6.

1.5.1 Charging the device

The device is delivered with a USB cable. You can choose between two ways of charging your device, via a computer or via the USB power (see 1.2.7). Once plugged in, the charge starts automatically and an electrical plug logo is displayed in the title bar. This logo appears in grey when the AUDIOSMART is charging and in green when the battery is fully charged.

The device battery is charged before shipment; however, it is recommended to charge it before the first use (we advise you to charge it for 12 hours before the first use).

When using the solution of connecting the device to a computer via the USB cable, charging will be slower than via a USB power adapter (see 1.2.7).



It is preferable to charge/discharge the battery as fully as possible to ensure a long service life. Charge the device to its maximum capacity and only charge it when it has reached a critical battery level.



To disconnect the device from the power supply, the USB power adapter must be disconnected.

1.8 Patient data confidentiality

The device collects data. It is the practitioner's responsibility to apply and comply with the European Parliament's General Data Protection Regulation 2016/679. When returning the device to the after-sales service, the user must delete the patient data from it so that it is not disclosed. The practitioner has the possibility to make a backup copy of the data by saving them in the **ECHOSOFT** software (see section 5.3.2) before deleting the patients from the device (see section 5.3.3.2).

The AUDIOSMART device is intended to be used by authorized healthcare professionals only. To ensure the confidentiality of patient data and to prevent disclosure to unauthorized third parties, a password can be set at the first start of the device. Please refer to section 2.1.3 for more information.



ECHODIA advises you to regularly renew the password of your device. It is also advisable to activate the lock mechanism of the computers on which you have installed the **ECHOSOFT** software after a short period of inactivity.

1.9 Cybersecurity

As the device and its **ECHOSOFT** software are computer-based systems that are integrated into larger information systems, certain rules and good practices must be put in place to ensure the safety of patients and users. Électronique du Mazet does not provide or control the operating environment of its products, so it is the responsibility of the practitioner to ensure that the following recommendations are followed.

1.9.1 Good practices for computer security

-Keep your software up to date, including the operating system (Windows or MacOs)

-Use operating system accounts to manage access.

-Use strong passwords to access accounts

-Lock down the computer when not in use

-Back up the ECHOSOFT database regularly (see 5.4.1)

-Verify the authenticity of any third-party software you install

-Use anti-virus software and a firewall

-Since the device and ECHOSOFT do not need to access the Internet, isolate the computer from the network as much as possible.

-Check echodia.com periodically to see if updates are available.

1.9.2 Technical Information

-The **ECHOSOFT** software is a Java program

-It embeds its own java execution environment (JRE+JVM) in order not to interfere with other software. (installed in the same folder, by default : *C:\Program Files\Echodia\Echosoft\jre*)

-The configurations of the software as well as the database are saved in the *.echosoft* folder of the user folder (ex: *C:\Us-ers\romain\.echosoft*).

-The software uses the port 32145 of the local loop (localhost / 127.0.0.1) in order to check that there are not several instances of the software launched at the same time.

-The software uses a proprietary USB driver to communicate with the device



Chapter 2

General information about using AUDIOSMART

2.1 Initial Start-up of the device


2.1.1 Switching on / starting

The device can be turned on without any other part connected. Turn on the power using the switch on top of the device (if it does not start, make sure the device's battery is charged)

2.1.2 Touch screen calibration

For the first start-up, it is necessary to calibrate the touch screen. The following window appears:

The screen has to be calibrated at 5 different points. Simply hold the stylus down on the cross at the center of each of the circles that appear successively.





Calibration is important for comfortable use. It is highly advisable to calibrate the device while holding it on a table, and using the stylus.

2.1.3 Password

After the screen calibration, the password definition windows appear. If you choose to set up a password, it will be asked to you each time you start the device. To do this, click on "Lock the device with a password" and set your password by clicking on "Change Password". The password must contain between 1 and 15 characters, and will be asked twice in order to ensure the proper seized of it.



You can access the password configuration window later from the "Measure" then "System" menu. This window allows you to change the password, but also to activate or deactivate the locking.

If you forget your password, please contact Electronique du Mazet or your reseller to receive an unlocking code.



2.1.4 Home screen

Once this step completed, the homepage appears:



Several items of information appear on this page. First, it contains the 3 possible selection parameters when the device is starting:

- USB: enables to activate the USB port of the device in order to recover, store and analyze the measurements made with it on a computer. Enabling the USB port of the device is also necessary for the realization of measures from a computer via the ECHOSOFT software.
- Measure: this is the main mode used for making and consulting measurements.
- Config: configuration of the various device options.

The homepage is used for choosing the system language by clicking on the flags at the bottom left of the screen.

At the bottom right, the serial number of your device is displayed.

A title bar is present on all windows of the device. From left to right, it contains:

- The current window title.
- The charge indicator (grey: charging. Green: charged).
- The date and time.
- Tha battery level.
- A button for returning to the previous window (on the homepage screen, it is used for switching off the device).

2.1.5 Switching off the device

To turn off the device, you can click on the back button at the top right of the home screen. A shutdown confirmation message will appear:

It is also possible to press the power button on the top of the device to bring up this screen from any browser window.

Energy saving mode: when you are not measuring, the device automatically turns off after 5 minutes of inactivity.



It is possible to force the device to turn off by holding down the power button at the top of the device during 4 seconds.



2.2 **General device configurations**


Some of the device general operating parameters can be configured. Accordingly, it is possible to set the time, date, brightness and orientation of the screen. To do this, just enter the configuration menu from the main screen.

The date and time can be configured from the "Date and Time" window

The "LCD" menu allows you to adjust the brightness of the screen with an adjustable gauge. The "Rotation" button allows the display to be rotated by 180°. This can

be useful depending on the location and position in which the device is used. It is also possible to recalibrate

The change to and from daylight saving time is not automatic.

The « Data factory reset » button resets the measurement parameters to the default values.


If you choose to set up a password lock, you will be asked for it every time you start the device (see).



The "**Calibration**" menu allows the consultation of the acoustic calibration values defined for your device.

The «About» menu contains the contact details of the

company Electronique du Mazet.



The **AUDIOSMART** device must be calibrated once every year to guarantee the quality of the measurements. Please contact your retailer to plan this calibration.



Some of these options require a password to be changed. This is the serial number of your device, indicated on the back of it on the S/N line. This number is also displayed at the bottom right of the home page.

2.2.1 Selection of the connected Jack headphone

In most cases, the unit comes with only one headset, which is properly configured at the factory. However, you have the option of changing the type of headphones that will be recognized when connected to the jack socket. If you have several headphones with a jack plug that have been calibrated for your device, you will need to go through this menu to switch from one to the other.



Never connect headphones that have not been calibrated for your device!



It is extremely important to choose the right model of headphone to ensure that the calibration is correctly loaded when using it.



Stimulators connected to the "Audio" input are automatically recognized by the device.

In the main menu of the unit, click on "**Config**". The settings window will open. Click on "Headset" to access the selection of the headset that will be recognized when connected to the jack. Select the headset model you will use and click "**Save**".





Chapter 3

Introduction and test setup

Audiometry is the basic review of hearing. This test allows a quick check of hearing, from the transmission chain to the brain. The measure is obtained through the emission of a calibrated frequency sound wave, of which we will lower the level until the patient can't hear it anymore. The sounds are emitted by a supra-aural headphone, in one ear then in the other.

Pure-tone Audiometry allows hearing thresholds screening for each ear in a frequency range from 125Hz to 8 kHz with regular headset and up to 16KHz with high frequency headset. Bone conduction evaluates performance of the inner ear and the auditory nerve, air conduction tests all of the acoustic function from the external ear to the auditory nerve. The interpretation of the resulting audiogram allows to know the degree of hearing loss and the kind of deafness. Pure tone audiometry also allows to find a discomfort threshold, or also the research for any tinnitus frequency.

Speech audiometry is a further investigation of the pure-tone audiometry. It does not determines a threshold of perception, but a threshold of intelligibility of language, or discernment of phonemes. The test consist of making the patient repeat a series of words he hears. By varying the power of diction of the words, a curve relating the percentage of discrimination in relation to the power is obtained. Well known by hearing aid specialist to fine tune the settings of hearing aids, it is also used to diagnosis retrocochlear pathologies like neuropathy or acoustic neuromas


3.1 Equipment

To make a **Audiometry** measurement you need the following equipment:




1 audiometric headset or the insert earphone





3.1.1 Setup





Using an otoscope, make sure that the ear canal is not obstructed by ear-wax. This operation must be carried out by a qualified person.

- To make measurement with **headset**, connect the cable on the Jack plug of the AUDIOSMART (indicated with the headset icon).
- For measurement with the insert earphone, put the tip on the **left** and **right** earphones. Then, connect the earphone Mini-DIN to the **«Audio»** connector of the **AUDIOSMART** unit.



• For bone conduction measurement, put the vibrator on the mastoid (or on the forehead for Webber test) and put a foam ear tip on the contralateral masking insert earphone. Then, connect the earphone Mini-DIN to the **«Audio»** connector of the AUDIOSMART unit.



- Explain to the patient the procedure for performing an audiometry.
- Put the headset on the head of the patient.



Chapter 4

Handheld mode measurement

4.1 Patient management

AUDIOSMART offers ideal measurement organization thanks to an advanced patient-based management system.

From the home page, select the "**Measure**" mode, leading to the choice of seeking an existing patient or creating a new one.

4.1.1 Create a new patient

If you choose to create a new patient, only 4 items of information are requested, the **name**, **first name**, **date of birth and gender**.

To enter this information, just click on the desired field to have the keyboard appearing on the screen. It is possible to use a digital keypad by clicking on the "**123**" key at the bottom left.





By entering the patient's date of birth and gender, it is possible to plot the audiometric normals.

To create a new patient, it is essential to specify a name and a first name. It is also recommended to specify a birth date, this allows a better patient organization in the **ECHOSOFT** data base.



The date must be entered in format **DD/MM/YYYY** (day/month/year). **AUDIOSMART** device automatically formats your enter.

Here, the information about the patient is kept brief. You can enter more details when you export the data to the **ECHOSOFT** program. Refer to paragraph 5.3



4.1.2 Patient follow-up

After you have created the patient, his or her record is recorded on the memory card. You can then find it by clicking on the "**Search**" button.

This brings up a table containing the list of patients, in the opposite order to the recording (the last added patient appears at the top of the list).

The list of patients appears with names, first names and dates of birth. The magnifying glass icon at the bottom of the screen enables to search for a patient thanks to his/her name or surname.

To select a patient, click on the corresponding line. This opens a new page summarizing information about the patient.

Now, it becomes possible to choose to make a new measurement (diagnosis) or to consult those previously saved (consultation).

If the patient does not yet have a measurement, only the **«Diagnosis»** button is visible.

The "**Consultation**" button opens a table of measurements allowing to consult the diagnoses previously made for this patient.

To find the desired measurements, the main information is displayed (type, date, time and ear).

4.2 Audiometry

Refer to paragraph 3 to obtain the necessary instructions about the needed equipment and the setup.

When you start a new diagnosis, the configuration window appears. It allows to start new measurement of **pure-tone Audiometry** or **speech Audiometry**. The "Graph" button allows you to view the graph at any time of the current measurement. The last button shows the active stimulation and can be used to switch between the two audio output. Thus, it is possible to keep the audiometric headset and the bone vibrator connected and switch between them by clicking on this button.

4.2.1 Pure-tone Audiometry

Once you select the **Pure Tone Audiometry** test you can choose among four modes of diagnosis.

- Automatic patient mode.
- Automatic doctor mode.
- Manual doctor mode.
- Weber Mode.



4.2.1.1 Patient mode

The patient mode allows automatic transitions of powers and frequencies. The doctor have to pre configure the test, then the patient is completely autonomous, he simply must click on the device to indicate that he hears the sound.

Measurement settings

Click on "**Settings**" then "**Frequencies selection**" in order to preconfigure the frequencies to run during the test. Once they are chosen, click on "OK" to validate.





All frequencies can be selected, however, the maximum and minimum stimulation frequencies may be limited when making measurement depending on the characteristics of the stimulator.

The icon of a floppydisk at the bottom right of the screen is used for recording the parameters defined above. They then become the default parameters for this type of measurement.





The "Settings" button opens a window allowing you to set the level of the masking noise as well as the starting power of the automatic protocols. Click "OK" to confirm

After selecting the ear (right or left), the **«Start»** button became available. Click on it to start the measurement.

Measurement

The **Tone audiometry** window open. The **AUDI-OSMART** device will automatically scan the pre configured frequencies and increase or decrease the stimuli power according to the patient answers.

The patient simply has to click on "OK" or on the response button when he hears the sound.

If the click has been taken into account, the button turns orange.



4.2.1.2 Automatic doctor mode

Automatic doctor mode allows automatic transitions of powers and frequencies. During the test, the device display the power and the frequency of the current stimuli. This mode allow the doctor to easily make a test while checking the patient responses.

Click on "Settings" then on "Frequencies selection" to preconfigure the frequencies to run during the test. Once they are chosen, click on "OK" to validate.






4.2.1.3 Manual mode

The manual doctor mode allows to change the frequency and power manually. This provides the possibility of making a custom testing protocol.


The bellow windows give access to the stimulation configuration.





To build the curve you have to specify the patient answer with the "**Yes**" "**No**" buttons for each stimulation (activated thanks to the "stim" button).

You can see the curve at any time by pressing the "**Graph**" button. Then you can **save** the curve by clicking on "**Save**", **delete** it by exiting the window or **continue** the measure by clicking on one of the boxes in the summary table.



4.2.1.4 Weber test


The Weber test can detect if the patient presents a strong hearing lateralization. This allows to set at best the contralateral masking noise power.

Patient setup

The Weber test is realized with the bone stimulator placed in the middle of the patient forehead.

Measurement

The bellow windows give access to the stimulation configuration.



The aim is to know for each frequency what is the threshold at which the patient hears on only one side. For each stimulation, indicate if the patient hears the sound at the left, right or on both sides.

You can see the curve at any time by pressing the "**Graph**" button. Then you can **save** the curve by clicking on "**Save**", **delete** it by exiting the window or **continue** the measure with the "**Measure**" button.



The saved data can be found in the "Consultation" patient menu.

4.2.2 High frequency audiometry

To make high frequency audiometry, it is mandatory to have a high frequency audiometric headset and have a license for the high frequency module. The headset must be selection in the menu « headset » under the configuration window (see 2.2.1).



It is extremely important to choose the correct headset model to ensure that the calibration is correctly apply when making measurement.




4.2.3 Speech audiometry

Measurement settings

When you start a new diagnosis, the configuration window appears. It lets you choose the type of list used, for example the disyllabic lists of Fournier.

AUDIOSMART is designed to allow you to easily perform a **Speech audiometry**. At the launch of the test, the device displays the words from the list on the screen. This list is randomly chosen to guarantee a reliable test, without the risk of the patient learning the words.


The "**Settings**" button allows to access the configuration window of the contralateral masking noise power. Click on the "**Start**" button to start the diagnostic





Measurement

From the launch window of the test, set the power and the ear to be tested before launching a "series" by clicking on "Start". Speech audiometry begins, the word currently spoken is written in red. If the patient correctly repeats the word, click on it to validate the answer.



Once the word series is complete, the device comes back to the start window. You can change the stimulation power according to the previous score and restart a new point.


If the patient correctly repeats the word, click on the corresponding box to validate the response

You can switch at any time between performing a new point and the graph by clicking the on the "Graph" button. When the test is finished, click on "Graph" to see the curve. You can then save it or make other Pure Tone audiometry or Speech audiometry measurements.



4.2.4 Measurement consultation

Refer to paragraph 4.1 for more details about patient management.



- The « **Measure** » button resumes the measurement and keep the already recorder information in displayed on the curves.
- The "**Tonale** / **Vocale**" switch between the pure-tone curve and the speech audiometry curve (available only if measurements had been made in these modes)
 - Pure-tone audiometry
 - The ordinate scale represents the hearing loss in dB HL.
 - The abscissa scale represents the frequencies in Hz.
 - The background of the curve represents the audiometric normal for this patient according to his birthdate and gender.
 - 1. The green area indicates a "more" than normal hearing level.
 - 2. The yellow area indicates a normal hearing level
 - 3. The red area indicates a hearing loss compared to the audiometric normal.
 - Speech audiometry
 - The abscissa scale represents the power of the stimuli in dB HL.
 - The ordinate scale represents the percentage of correctly repeated words.
- The last image on the right shows the information obtained by clinking on the graph area
 - Criteria used for the normal audiometric curve
 - Item used in the graphics:
 - The blue curve with crosses is for aerial measurement on the left ear.
 - The red curve with circles is for aerial measurement on the right ear.
 - The dotted blue curve with brackets is for bone conduction measurement on the left ear.
 - The dotted red curve with brackets is for bone conduction measurement on the right ear.
 - The dotted white curve with red and blue brackets is for the Weber test.
 - Headsets used for aerial and bone audiometry

5.2.2 Installation des pilotes USB

AUDIOSMART has a generic USB driver mass storage, it is recognized and installed automatically.

This driver will enable the transfer of the data collected in ambulatory mode in the l'ECHOSOFT's data base. You can also use your AUDIOSMART device directly from your computer (PC or Mac). You will need to install a USB driver to have this functionality. Since the version 2.1.6.0 the USB driver installation is automatically trigger during the ECHOSOFT installation process but, for some reasons, you could have to do a manual installation, for this purpose, in the main window of the software, click on "Devices", then on "Data". The main window will change, you need to click on "install USB driver" at the bottom right.

The software automatically launch the driver installation. Once the installation is over, it is necessary to unplug and then plug back on the device to finalize the process.



To optimize the life length of the battery, the screen will turn off after two minutes when the USB mode is activated and that the device is plugged to a computer. To turn it back on, click on the "On/Off" button or touch the screen.

5.3 Patient management



The **ECHOSOFT** software is capable of reading measurements made using **AUDIOSMART**. it incorporates a database in which the patient data and measurements can be stored.

5.3.1 Create new patient

After installing the software, there is no patient in the database, before starting a new measurement, a patient must be created. To create a patient, click on the "**New**" button on the "**Patients**" frame on the left of the screen.

Several types of information are available, some of which are mandatory such as title, surname, first name and date of birth. Indeed, the date of birth is used to display the audiometric normal, so it is important to fill it in correctly.

All information related to a patient can be modified. To access the patient record screen, select the patient and click on the "Edit Patient's Profil" at the bottom of the main screen.

5.3.2 Import patient from device

Connect the device to the computer to import patient data into the ECHOSOFT.

Start the device and connect it to the computer using the supplied USB cable. From the homepage screen, select the "USB". The device should be detected by the computer.

For the first plug of the device, the USB driver should be automatically installed. See subsection 5.2.



Start the **ECHOSOFT**. Go to the section entitled "**De**vice" then click on "Data".

If the device is connected properly and the USB driver is running, the list of patients is refreshed automatically.

There are then 3 possibilities for importing the patient and making measurements:

- Add a patient to the data base
- Synchronize all patients with the data base

- Synchronize all patients with the data base in fast mode





5.3.2.1 Add a patient to the datebase

Select the patient(s) to be imported from the list, then click on "**Save to database**". The software will then ask you for the information for the whole selection before importing the data.

To register a patient in the database, it is necessary to indicate the doctor or the operator who performed the measurements. If the operator already exists in the database, it is sufficient to select him and then click on Validate. If not, it is possible to create a new one (see the paragraph on how to create an operator). The "**Cancel**" button imports the patient, but does not associate any operator to the measurements

A detailed patient information form is provided. You can add information such as address, phone number, etc.

Once filled in and validated, a series of treatments is executed by the software.

If the patient has been correctly imported, his name appears in the "Patient" section of ECHOSOFT.

If the patient already exists in the database, it will be
automatically recognized and synchronized with the pa-
tient of the device.

If several patients in the database are likely to correspond to the patient being imported, **ECHOSOFT** offers the possibility of choosing the corresponding patient or simply creating a new one.

5.3.2.2 Synchronize all patients with the database

This option lets you add all of the AUDIOSMART patients to the ECHOSOFT database. The software will automatically scan the list of patients on the AUDIOSMART to add them to ECHOSOFT, if the patient does not exist, a new patient file will appear to be filled. On the contrary if the patient is already on the database, it will automatically be synchronized.

If you select some patients in the list before launching the registering in the database, the software only synchronize the patients that have been selected. If you have a large amount of patient stored on the device, making a selection enables to synchronize rapidly your data.

5.3.2.3 Synchronize all patient with the database in fast mode


This option lets you add all of the AUDIOSMART patients to the ECHOSOFT database with only one click.

The software will automatically scan the list of patients on the AUDIOSMART to add them to the ECHOSOFT, if the patient does not exist it will be automatically created with the information present on the device. On the contrary, if the patient is already present on the database, it will automatically be synchronized.

This synchronization has the advantage of not requiring any intervention from the user.



To use this mode, it is advisable to have carefully filled in the information of the patients at the time of their creation on the **AUDIOSMART** (name, surname, date of birth and gender).

5.3.3 Delete a patient

Using **ECHOSOFT** it is possible to delete patient recorded in the database and patient recorded on the device.

5.3.3.1 Delete a patient from ECHOSOFT

A patient can be deleted from the **ECHOSOFT** database via the "**List of patients**" window in the "**Patient**" section. The "**Edit patient's profile**" button is used to consult and modify the contact records of the patient selected in the list. The "Delete" button is used to definitively delete the patient from the ECHOSOFT database.

- Select another database: select a database located in another folder. It is possible to select a database located on your computer, on a USB key or a network shared folder*.
- **Relocating the database:** move the current database to another folder. It is possible to select a local folder, a USB key or a network shared folder*.
- Create a new database: create an empty database in a new folder. It is possible to select a local folder, a USB key or a network shared folder*.
- Use the default database: restore the default configuration (database located in .echosoft in the user folder).
- **Backup database:** create a backup of the current database, the backup is located in .echosoft in the user folder. The backup file name contain the data and time.



*In the case of a network shared folder, it is not recommended to have write access (create patient, record measures ...etc...) by several users in the same time.



5.4.2 Medical software

This section is used to configure a third-party patient management software to import audiometry curves.

A first drop-down menu lets you select the software used. Next, you must define the location where the **ECHOSOFT** software will retrieve the patient information. Finally, you need to define the location where the **ECHOSOFT** should store the results once the measurement is completed, so that the third-party software can retrieve the curves.


The maximum frequency during testing may be limited depending on the stimulator (headphones) used. For stimulation above 8000Hz, you need the "HF Audiometry" module and a high frequency headset.

- 2. The automatic threshold measurement mode searches for a patient's hearing threshold over the range of frequencies preselected in 1. The frequencies are scanned from 1000Hz to the highest frequency, then from 1000Hz to the lowest frequency. The repetition of the test at 1000Hz depends on the selection of the "double validation at 1000Hz" box. For each frequency, the test starts at the selected "starting power". The automatic algorithm performs the power changes according to the rising threshold method, respecting the "maximum power" and "minimum power" settings. The "Response Time" is the time limit after the stimulus presentation during which the patient's response is considered valid. The intervals between two stimuli are randomly modified according to the maximum and minimum intervals set.
- 3. The modifications must be validated by clicking on « Save ».



5.4.4 Impression

There is two printing model in **ECHOSOFT**, one with a full note taking page first and measure results on the others pages (standard layout) and another model with the measure results first and the potential notes at the bottom of the page (compact layout). This setting is available in **« Settings », « Printing »**.

The **ECHOSOFT** gives ability to use the **AUDIOSMART** as a peripheral to make measurement and diagnostic directly from your computer (PC or Mac).

See subsection 5.2 to install **ECHOSOFT** and needed driver to make measurement.

Start the **ECHOSOFT**, the window below appears. Connect the device to the computer and click on the **USB** button from the home screen of the **AUDIOSMART**. The **Audiometer** button (3) becomes available above the list of subjects after connection, otherwise check if the driver has been correctly installed.

If the patient already exists in the database (2), you just need to select it, otherwise, it is possible to create a new one (see 5.3.1). When the patient in selected, the **Audiometer** bouton become available, click on to start the measurement.



5.6.1 Pure tone audiometry

See subsection 3 to obtain the necessary instructions about the needed equipment and the setup. By default, the audiometry starts up on the Pure Tone mode. It is possible to change the mode via the tabs at the top left of the window.



There are three different modes enabling the adjustment of the acoustic stimulation characteristics:

- Move the mouse over the graphs, and click to start the stimulation. Press the **"Enter"** button to validate the patient's response,
- Control the interface with the keyboard (See subsection 5.10),

 - The automatic mode can be stopped at any time by clicking on the same button,
- 5. Patient response, the **«Enter»** key correspond to a click on **«Yes»** button,
- 6. This button launches an explanatory message in the patient headphone. This message describes the measurement progress and gives an example of stimulation,
- 7. Set the stimulation power, can by modify with **«up»** and **«down»** keys,
- 8. The whole green area is dedicated to the masking noise. In the upper part, the power and frequency band of the noise are indicated. Just below, the box "**Continuous masking**" allows to have a permanent masking (if it is not checked, the masking starts at the same time as the stimulation). The lower part consists of the tabs for selecting




the masking mode, and the corresponding setting:

- Differential mode: The value set via the cursor is the gap between the stimulation power and the masking power (ex: for a differential of -30dB, for a stimulation at 80dB, the masking power will be 50dB).),
- Manual mode: The value set with the cursor is the masking power.
- See 5.8.2 for the automatic mode
- 9. The "**Headphones**" button allows you to see which stimulator is active and to switch between the two audio outputs. Thus, it is possible to connect the headphones and the bone vibrator (each to one of the audio outputs) and switch between the air conduction and bone conduction test.
 - A click on the keyboard icon shows a reminder of all keyboard shortcut (See subsection 5.10)).
 - 10. Indicator light show that a stimulation is in progress,
 - Green: no stimulation,
 - Red: stimulation is running.
- 11. Save or create a measurement,
- 12. The cross represents the current position of the mouse cursor, make a "left click" to start the stimulation. If the patient has heard, you can validate the response by pressing "Enter".

For more details about measurement presentation and analysis, refer to subsection 5.7.

5.6.2 Speech audiometry

ECHOSOFT enables Speech audiometry measurement, to do that, just go to the second tab of the audiometry window.



- 1. Displays the Speech audiometry's lists available on the software, it is possible to select the language, type of the list and pronunciation,
- 2. Displays in bold the word that is currently being spoken in the patient's headset. On the left the previous word is displayed and the next word is on the right. When the patient repeats the word correctly, a simple click on the word validates it (the word turns green), a second click cancels the validation. It is possible to validate the current word or the previous one.
- 3. Control starting, pausing and stopping a list. The gauge below shows the progression of the current list,
- 4. By default, the word list are played randomly but by clicking on this button it is possible to choose which list must be play,
- 5. This button allows you to import new lists on the software (If you have no list installed, click on this button to import lists previously downloaded from http://echodia.fr/firmware/vocal/).



- 6. This option will pause the list after each word.
- 7. Set the stimulation power, can by modify with **«up»** and **«down»** keys.

Select the stimulation ear side, can be switched with $\ll L/R \gg$ keys.

- 8. The whole green area is dedicated to the masking noise. In the upper part, the power and frequency band of the noise are indicated. Just below, the box "**Continuous masking**" allows to have a permanent masking (if it is not checked, the masking starts at the same time as the stimulation). The lower part consists of the tabs for selecting the masking mode, and the corresponding setting:
 - Differential mode: The value set via the cursor is the gap between the stimulation power and the masking power (ex: for a differential of -30dB, for a stimulation at 80dB, the masking power will be 50dB).),
 - Manual mode: The value set with the cursor is the masking power.
 - See 5.8.2 for the automatic mode
- 9. The "**Headphones**" button allows you to see which stimulator is active and to switch between the two audio outputs. Thus, it is possible to connect the headphones and the bone vibrator (each to one of the audio outputs) and switch between the air conduction and bone conduction test.
 - A click on the keyboard icon shows a reminder of all keyboard shortcut (See subsection 5.10).
- 10.Indicator light show that a stimulation is in progress,
 - Green: no stimulation,
 - Red: stimulation is running.
- 11.Save or create a new measurement,
- 12.Real-time display of the percentage of correctly answered words according to the intensity. A right click on a point gives the possibility to delete it and to check which words have been pronounced correctly

A new measurement consultation window opens. Select **Audiometry** from the drop-down list at the top left of the window.

The measurements are displayed chronologically in the "**Left/Right**" columns according to the ear selected at the time of diagnosis.





5.7.2 Description of the measurement window

1. Display area of the **pure tone audiometry** graph:

- Abscissa: frequency in Hz.
- Ordinate: power in dB HL.
- The blue curve with crosses is for aerial measurement on the left ear.
- The red curve with circles is for aerial measurement on the right ear.
- The dotted blue curve with brackets is for bone conduction measurement on the left ear.
- The dotted red curve with brackets is for bone conduction measurement on the right ear.
- The red dot with a bottom left arrow: the sound was played but the patient didn't answer (right ear).
- The blue cross with a bottom right arrow: the sound was played but the patient didn't answer (left ear).
- 2. Summary table of standard audiometric indicators.
- 3. Weber test display area.
 - Abscissa: frequency in Hz.
 - Ordinate: power in dB HL.
- 4. Display area of the **Speech audiometry** graph:
 - Abscissa power in dB HL.
 - Ordinate: percentage of correctly repeated words.
 - The blue curve with crosses is for aerial measurement on the left ear.
 - The red curve with circles is for aerial measurement on the right ear.
 - The dotted blue curve with brackets is for bone conduction measurement on the left ear.
 - The dotted red curve with brackets is for bone conduction measurement on the right ear.
- 5. Note input.
- 6. Excel export of the measurement,
 - Print options,
- 7. If a device is connected, it is possible to resume the measurement,
- 8. Information about the AUDIOSMART used for the measurement.



5.8 Masking calculation help


The fourth tab of the audiometry window gives access to the patient's measurement history. A double click on the date of the measurement will display it in the background (in transparency) to compare the current measurement with the selected one.



The automatic calculation system is only intended to make the operator's work easier; it is his responsibility to check whether the calculation method (see 5.8.3) is suitable for the specific case of each client.

In some cases, after a measurement without masking, the operator sees the need for a second test, by masking the frequencies where there was potentially a transcranial transfer (ghost curves). An automatic masking calculation module has been developed to help operators to calculate a suitable contralateral masking, for frequencies between 250 and 8000 Hz, from a previous test performed without masking.

When selecting a measurement in the "**Historic**" (1) which contains the air and bone tests, a table with suggestions for the masking differential to use (3) is displayed. At the same time, the "**Auto Mode**" becomes available as a masking control (2). It allows to automatically apply the masking differential suggested in the table (3) depending on the side (right or left), the stimulus (air, bone or speech) and the frequency.



The masking in "**Auto Mode**" is calculated by applying the differential to the stimulation power sent. Thus, it varies with each change in stimulation power, unless it reaches the limit set by the operator, or the limit of the stimulator output power. Masking can be activated continuously (by selecting the "**continuous masking**" box) or at the same time as the stimulation. In case where it is not necessary or if it cannot be calculated, the level is set to -30dB (no masking).



The masking for bone audiometry will only be calculated for the "history" frequencies tested by air conduction (AC) and bone conduction (BC) in both ears. For AC audiometry the same rule is used, except for the frequencies 6 and 8 kHz. For these frequencies, BC audiometry is not mandatory for the calculation of AC masking. Finally, for speech audiometry, the AC and BC thresholds of both ears for at least one frequency (between 500Hz and 2 kHz) are required. The calculation of the applied differential is performed as described in the section 5.8.

- Red: missing information to compute the masking value (for example, the contralateral ear has not been tested)

5.8.2 « Automatic mode » audiometry with « Auto mode » masking

When using pure tone audiometry in "Auto Mode", with masking in "Auto Mode", only the frequencies shown in the table with a yellow background will be tested (respecting the type of stimulation used - AC or BC). Make sure that all the frequencies present in the reference test (from the "historic" tab) are activated in the configurations so that the test with masking, if necessary, can be performed.

5.8.3 Calculation method

Air conduction audiometry (AC):

If the difference between the AC threshold of the test ear and the BC threshold of the contralateral ear (CtL), at the same frequency, is equal to or greater than the AC interaural attenuation (AI_AC), then masking is required. Different types of stimulators may each have a specific AI_AC value (insert = 50dB; headset = 40dB). Therefore, the need for masking and its value may vary depending on the stimulator used, which is automatically identified by the module.

In order to calculate the AC masking, the AC and BC thresholds of both ears at the frequency to be analyzed are required (except for 6 and 8 kHz). If there are no BC thresholds at 6 and 8 kHz, the module calculates the average Rinne (difference in thresholds between AC and BC) between 2 and 4 kHz and adds this value to the 6 kHz and/or 8 kHz AC threshold to obtain the estimated BC threshold.

Efficiency criteria:

$$Differential = Rinne_CtL + 10dB - AI_AC$$

Maximum masking level:

Max differential = $AI_AC - 5dB$

Bone conduction audiometry (BC) :

If the BC threshold of the test ear is higher than in the contralateral ear (CtL), at the same frequency, or if the Rinne of the test ear is greater than 10 dB, then masking is necessary.

In order to calculate the BC masking, the AC and BC thresholds of both ears at the frequency to be analyzed are required.

Speech audiometry:

If the average AC threshold for conversational frequencies (between 500 and 2000 Hz) of the test ear minus 60 dB is greater than one or more of the BC thresholds of the CtL ear, then masking is required.

In order to calculate masking for speech audiometry, the AC and BC thresholds of both ears for at least one frequency (between 500 Hz and 2 kHz) are required. The results obtained at 250 Hz are not taken into account for the calculations.



Blue : currently selected frequency. In « Speech » audiometry, no frequency will be selected, the module will apply the appropriate masking for speech audiometry

Efficiency criteria:

Differential = Rinne_CtL (the highest) + $10dB - AI_AC$


Maximum masking level:

Max masking (Insert) = best ipsilateal BC threshold + AI_AC + 5

5.9 Merge measurement

There are two ways for displaying two measurements on the same graph:

- Select the measurement in « historic » tab while doing a measurement (see 5.8).
- Keep the « ctrl » key pressed and select two measurements in the consultation window (see 5.7).



When there is more than one measurement represented in the graph, the curves will be shown with their respective dates and times (In the example above, only the right side has two measurements).

By showing two measurements at the same time, in addition to being able to compare them and to allow the use of a help in the calculation of the masking, it is possible to merge them. The "Merge" button (in the lower right corner) lets you create a third measurement by combining the two. There are two different ways to determine the prevalence in case there is more than one value, for the same frequency in tone audiometry or the same intensity in speech audiometry, at the time of combination:

- Focus on threshold: data indicating a lower hearing loss will be preserved.
- Focus on the date: the data of the oldest measurement will be replaced by the data of the most recent measurement



In addition to the visual controls on the software, you can perform the audiometry manually with the keyboard of your computer.



5.11 Use of the microphone

ECHOSOFT allows you to use the computer microphone to communicate with the patient, in the case where the patient is in an audiometry cabin and the operator is outside.

The microphone setup is done thanks to the third tab at the top left of the audiometry window.

It is possible to select the input device (the device list will depend on the computer and the sound card).

It is possible to adjust the input gain (this will depend on the computer and the sound card). Finally, you need to adjust the power at which the sound will be sent in the patient headphone.

The volume is indicative, it may vary depending on the microphone, computer and speech of the operator.

To use the microphone, keep the "A" key pressed and speak (the light indicator at the bottom left then turns red).



Chapitre 6

Maintenance and servicing

6.1 Periodic checks

Before testing, consider checking:

- The presence of the acoustic stimulus and the correct power calibration.
- The absence of interference in the incoming signals.
- The general functioning of the device.

Replace the unit and its peripherals in the original case after each use.

The AUDIOSMART device is reliable and safe for the patient. In order to maintain this safety, it is imperative to follow the operating instructions provided in this manual.

AUDIOSMART devices are designed to have a service life of 5 years.



To ensure that the performance of the device is maintained throughout its life, it is necessary to have the device checked by Electronique du Mazet technicians or its distributors every year.



All cables supplied are made of EMI resistant materials. To maintain these properties, it is advisable not to bend, pinch or pull the cables.



Surface electrodes have an expiry date, so be sure to check this date before each use.

6.2 Cleaning



This device is not sterile, Accessories are not sterile

6.2.1 Device case

The device case only requires normal, periodic cleaning of its external surface, which may become dirty.

The touch screen should be cleaned with a soft, dry cloth, **without any product or water**. Clean the rest of the appliance only with a dry or slightly wet cloth.



Do not use any liquid or spray to clean the unit, as this may damage the electrical circuits.



6.2.2 Accessories

In order to ensure perfect hygiene, it is essential to systematically clean all material and equipment in direct contact with the patient.



All consumables (surface electrodes and ear tips) are disposable, discard them after use.
